Factors such as Low socio-economicstatus, Maternal age (<20yrs and >35yrs), Not breastfeeding, Poor maternal nutrition, Maternal obesity, Latebooking for antenatalcare, uncontrolled smoking and alcohol conception at the time ofpregnancy, Maternalmorbidity (diabetes, hypertension) and Low birth weight. Peopleshould decrease smoking at the time of pregnancy and improve the quality of antenatal care is required to prevent form the above risk factors.
